CHALLENGE

The production environment used by SaaS could not handle a growing number of users. Existing architecture didn't allow rendering significant changes and optimisations to meet new demand.

CI/CD workflow was not convenient enough for developers if they needed to deliver new fixes and features in a prompt fashion while it was crucial for business success.


An overall 24×7 support was required to monitor and handle all infrastructure- and DevOps-related incidents whenever they occur. The more users were active and the bigger infrastructure became, the higher responsibility level was required.

SOLUTION

To address developers' needs, a **brand new CI/CD system** was introduced. It was fully automated, easier to use, and provided developers with essential features, such as a transparent deployment process. Additionally, ongoing consulting was offered to help developers follow software delivery best practices. These changes led to accelerated onboarding for new developers.

For the production environment, a **highly available Kubernetes cluster** was deployed. It allowed ComplAi to automatically scale infrastructure according to evolving needs, withstand various failures, and simplify the application deployment process.

A **comprehensive observability solution** was implemented to ensure new infrastructure reliability. It covered three layers, i.e. blackbox monitoring, infrastructure and applications monitoring. Combined with a **dedicated DevOps** & SRE team and 24/7 support, it guaranteed robust operation for business-critical applications.

OUTCOME

The DevOps & SRE service by Palark eliminated the bus factor. All related issues are now handled by a team (instead of a sole engineer) — therefore, they are resolved in a timely manner. It resulted in the following benefits for the customer:

- Tremendous MTTR (mean time to recovery) reduction, from 0.5 days to 0.5 hours. Well-established observability system and incident management workflow significantly contributed to this. While duty engineers now react to critical incidents within 5 minutes in a 24/7 mode, there are powerful mechanisms and tools to deal with them swiftly.
- 2. **Better security.** Automated CVEs (common vulnerabilities and exposures) scanning in the CI/CD pipeline minimised security risks in the production environment.
- 3. Development team growth enablement. Embracing new CI/CD workflow and further DevOps-related assistance helped ComplAi to expand the development team by 50% within the first few months of our collaboration.
- 4. Improved user experience. The log collection system was introduced as a part of the observability solution. It serves developers as an indispensable assistant when they need to reproduce any issues reported by users and troubleshoot them to provide users with a prompt fix.
